

April 21, 2022 Quilt Show meeting

Meeting started at 1:15 p.m. at Atonement Lutheran Church in Newport, Oregon

We need a hostess coordinator as soon as possible. Wilma described the position details and their responsibilities are for supplying volunteers for Friday and Saturday only. Because this position is very busy 3 to 4 people are needed on the team.

Wilma is requiring all committee chairs to furnish a written description of what the job entails after the quilt show. The chair notes will be put into a manila envelope for the next committee chairs, making it easier for future committee chairs to do know what is needed.

Wilma will announce the committees that need to be filled at the next general quilt show meeting.

Tracy is very excited to be the food vendor again this year with a group of 4-H members.

Wilma will check with the Newport Recreation Center to see if they set up tables for the show or not.

Jane Towsley, Penni Myers and Jackie Stankey have signed up for the quilt hanging committee.

Currently no one has volunteered to chair the Demonstrations committee. Discussion was about asking vendors and guild members do demonstrations. We have lots of talented members who could demonstrate ideas, tricks, or how-to-do, such as PPP, paperless paper piecing. If the position isn't filled by the next guild general meeting Wilma will announce it. If the position isn't filled it demonstrations won't happen this year.

Jackie Stankey will contact Kathleen Ritzman for name and phone number for Latter Day Saints quilt hanging helpers.

Discussion regarding how to make signup sheets for Thursday, Friday and Saturday. The Thursday potluck committee will make a signup list for that day.

Linda Reeve reported on ribbon order. There are supply issues, and order needs to be placed by 1st week of June. The ribbons held in storage need to be replaced due to damage and wrinkles that cannot be removed. Linda needs information on where to order participation badges.

Janet Baldwin will send latest updated committee list to Jean Amundson.

Kathleen Ritzman reported vendor committee has 3 paid vendors so far. She has contacted possible vendors in California, Washington and Oregon. She also sent reminders to vendors she invited earlier. Barbara Kinzel will contact Roseburg quilt show regarding vendor participation at their 2022 show for suggestions, ideas and information.

Becky Mershon will contact Nan Scott about using the Square at the show. Becky has shopping bags available for purchase by quilt show attendees.

Meralee Wilson reported she needs to order drapes and poles. She will check prices at place she used last time. Someone suggested some might be in our storage from Jannilou's. Meralee will order pipes same as last year. Nan Scott has drapes available from her church in Yachats.

Some people who registered quilts did not get a confirmation email and don't know if their quilt was registered or not.

Linda MacKown, Indoor Signs, verified entrance fee, and hours of show. The entrance signs Linda has show the opening hours at 9 a.m. but the 2022 hours are 10 a.m., the decision was not to order new ones this year and open at 9 a.m. Linda also sent around list of inside signs for committee chairs to verify signage.

Basket Table, Linda Reeve, described idea and suggestions with samples she made. Lindanne Perdue will provide fat quarters from Community Quilts supply. Linda will send Linda McKown the information needed for her indoor sign.

Meralee Wilson said grab bags supplies are going well.

Lindanne Perdue said the quilt show program needs to be updated. Patti Stephens and JoAnne Sedlacek did it last time. Wilma will call Patti to see if she is interested in doing it this year.

The Program Committee needs to decide the placement each quilt and include the Quilt Hanging Committee in their meeting. Darcy de la Rosa volunteered to do the computer part. The final quilt registration date is July 4th.

Pamela Potter has a question about the money box and will call Janet Sylvester for more information.

Sponsored ribbons will not be needed if no one signs up to chair the committee. Wilma will announce opening at next meeting.

The same judge will be used as 2021 show that didn't happen because of Covid. Darcy suggested members have quilts judged to receive constructive comments or critique.
